The City Council of the City of Cameron met in Regular Session on January 7, 2013 in council chambers of the Benedum Community Building. SCHEDULED ON AGENDA: Budget Revison #5 was presented to council for review. The revision was to bring the Pool Donations up to current.

FINANCE REPORT: Wayne Simmons read the Finance Report for January 7, 2013. General Fund totaled \$184,032.57, Coal Severance Tax totaled \$3,000.00, Water Fund totaled \$27,804.33, and Sewer Fund totaled \$13,894.75. Complete total was \$228,731.65.

Wayne Simmons noticed that there was a significant drop in the Operating Cash. Cindy responded that there had been several items paid out.

POLICE: Chief Younger was not present but did prepare a report for council to review. There was discussion regarding a requirement period for Ryan Hickman to stay on board after completion of the academy. It has been requested that we confirm this with Chief Younger. Wayne Simmons responded that he believed that there was a time period that t training would be paid back if the individual left within a certain time frame.

Mayor Beresford reported that Ryan Hickman was now in training at the academy.

STREETS/ALLEYS/LIGHTING: There were 3 streets lights that were not working properly. Sgt. Patrick Mull prepared a list with the pole numbers for the clerks to call in to AEP. Mayor Beresford reported that the pole by her house is out as well. She will get the pole number and get back to us with it.

Cindy also reported that Paul Garey was to come and take down the Christmas lights but has not seen him as of yet.

VEHICLE MAINTENANCE: Mayor Beresford reported that the green truck was out of commission. She also reported that she is searching other avenues to finance another truck.

Rock inquired with Rosemary Humway-Warmuth if, since we are in an emergency type situation, would it be o.k. to go out and buy a truck. Rosemary replied that she would not advise that. She suggested placing it out for bid.

SEWER: Mayor Beresford reported that the plant was running well.

UNFINISHED BUSINESS: Rock Guzek asked if an estimate was received from ERB for the electrical issues at the plant. Mayor Beresford responded that he should speak to Tim Flint regarding that issue. ERB was at the plant. Cindy Minton replied that she has not received an estimate in the mail yet.

NEW BUSINESS: Tom Hart suggested that the Mayor check into the state requirements on the 4x4 trucks. Rosemary Humway-Warmuth said that she would check with someone in her office to get the number for the Division of Purchasing to inquire as requested.
