APPROVAL OF MINUTES:

Councilperson Sarah Burge moved to approve the Minutes for March 18th, 2024, seconded by Councilperson John "PZ" Winters. Motion passed 4 YES, abstained by 1.

PUBLIC COMMENTS:

David Evans spoke on the sewer problem down at 171 Main Street. He has some thoughts on how we see exactly what the issue is, and how to fix it. Said Jeff struggled with all the water at the sewer with the excess of rain we had the previous night. He also asked if the town would have a bigger impact with the flooding if the dams went away. Mr. Evans and a couple of others are putting a committee together to try to let Charleston know how the coal mine is impacting towns in WV.
