# STATE OF WEST VIRGINIA, COUNTY OF MARSHALL, CITY OF CAMERON, CITY COUNCIL, REGULAR SESSION, September 8<sup>th</sup>, 2021.

The City Council of the City of Cameron met in Regular Session September 8th, 2021, from the Benedum Community Building. Mayor Greg Galentine called the meeting to order at 7:00 p.m. The following council members were present Joseph Wendt, Kenny Richmond, Terri Galentine, John "PZ" Winters, Sherry Johnson, Christian Turak and Chief Dougherty. Councilperson Sarah Burge, absent.

#### **PLEDGE OF ALLEGIANCE:**

#### **APPROVAL OF MINUTES:**

1) Councilperson Kenny Richmond moved to approve the minutes as presented August 16th, 2021, meeting, seconded by Councilperson Terri Galentine. Motion carried, vote of 5 YES.

#### **PUBLIC COMMENT:**

• Steve Haines from Thrasher Engineering, LLC visited Cameron to explain to council and residents about a possible water extension. The city has been approached by two residents requesting to be provided water. To connect those two residents roughly looking at 1700 ft. Thrasher proposed going an additional 1700 ft. By doing so, another 15-20 residents could benefit for the secondary water source. Councilperson John "PZ" Winters questioned Right of Ways. A lot of the area in the scope of this work is under DOH / coal mine. Would like to send our council out to speak with residents in area where possible extension. Would like to see if any interest from the residents. Steve with Thrasher will be looking into possible funding available to apply for.

Current Sewer Project update is Mason Dixon will start working at WWTP on September 10,2021. Ordered items have finally arrived due to delays because of COVID. First project is Bar screen area. Rough estimate on some other items with the system look to be shipped mid-October.

Manholes rebuild to start end of September. Thrasher Engineering, LLC is still waiting to hear NCRS & DEP regarding finishing the sewer line improvements in and around location north bound RT 250. Estimates should be received by end September. To get the work started again in that area.

Matt Haines is working on compiling videos and marking each manhole. Thrasher will also start Smoke Testing sewers in the City of Cameron this week.

Ricky Beresford owner of property located on 109 Main Street Cameron; WV
approached council requesting to put a driveway in on their empty lot. This will
enable residents to park their vehicles off the main street.
