APPROVAL OF MINUTES:

 Councilperson Sherry Johnson moved to approve the minutes as presented for July 17th, July 24th, and August 10th, 2023, seconded by Councilperson Stephanie Neely. Motion carried, vote of 4 YES.

PUBLIC COMMENT:

- 1) Mary Leichter came back to speak with council requesting council to reconsider the approved vote to tear down the stage located at the Recreation Park and Rescind their vote. Mary shared ideas to utilize the stage for live bands, food trucks, etc. Mary has also posted a survey on Facebook asking for feedback from residents, also gathering signatures on a petition asking for an extension on removal of the stage. After discussion the council stayed with the original vote to allow the stage to be torn down. Mayor Greg Galentine stated he was going to speak with Mr. Larry Hartley about the removal of the stage.
