The City Council of the City of Cameron met in Regular Session November 2, 2020, from the Benedum Community Building. Mayor Greg Galentine called the meeting to order at 7:00 p.m. The following council members were present VIA TELEPHONE CONFERENCE: Sarah Burge, Joseph Wendt, Kenny Richmond, Terri Galentine, PZ Winters, and Sherry Johnson

PLEDGE OF ALLEGIANCE:

APPROVAL OF MINUTES:

Councilperson PZ Winters requested for an address in his comment section to be corrected. 29 North Ave. corrected to read 24 North Ave. Councilperson Sherry Johnson moved to approve the minutes as presented with correction made for October 19, 2020 meeting, seconded by Councilperson Joseph Wendt.
