APPROVAL OF MINUTES:

Councilperson Sherry Johnson moved to approve the Minutes for April 1st, 2024, with the corrections made under councilperson Sarah Burges comments, seconded by Councilperson Sarah Burge. Motion passed 5 YES.

PUBLIC COMMENTS:

- Steve Haynes from The Thrasher Engineering Group spoke with the council regarding upcoming project progress.
 - Water Project was awarded 1.5 million in Grant Funds. Moving forward on design plans and permits. Steve Haynes also went over the Rule 42 that must be completed by a CPA prior to applying for said grants.
 - Sewer Project is moving along. Permit and bond have been approved.
